He/She will be disqualified by appointing. (2). Interview call letters will be issued to shortlisted candidates only. (3). Shortlisting will be based on screening test conducted by ETEA. (4). Candidate should be eligible by the last date of receipt of application. (5). Incomplete applications and applications received after due date will not be entertained. (6). Age Relaxation will be admissible as per Government rules. (7). Candidate working in Governments/Semi-Autonomous bodies should apply through proper channel. (8). Candidates intending to apply for more than one posts should apply separately with separate fee. (9). Number of vacancies can be increased/decreased. (10). Competent authority reserved the right to cancel/reject any application with assigning reason. (11). Candidate mentioned at S.No. 4 in SD Wazir table will be recruited for EPI purpose only. (12). NO TA/DA is admissible for test/interview. (13). In case of foreign degree, relevant certificate from HEC must be provided. (14). Preference will be given to the Candidates having Domicile of District Bannu for table No.1 and preference will be given to candidates having domicile of Sub Division Wazir (Ex-FR Bannu) for table No.2. Take Print out of the generated UBL deposit slip and deposit Rs.500/- as test fee (Non-refundable) in any branch of UBL on that prescribe printed deposit slip of UBL. (4). After Successful submission, please keep original deposit slip(candidate copy) having bank stamp with yourselves and do not share it with any one. (5). After online apply, DO NOT send documents to ETEA Office. However, Copies of testimonials/documents will be provided by candidates who qualify screening test as and when required by ETEA or appointing authority for scrutiny purpose. (6). Availability of online application form on www.etea.edu.pk on **24th March, 2021**. (7). Last date for submission of online application is **12th April, 2021**. (8). Candidates will be informed through SMS by ETEA to download and print their Roll No Slips from www.etea.edu.pk. Furthermore, candidates are advised not to provide portable/converted Cell number. (9). Test date, time and venue will be mentioned on Roll no slips. (10). No separate call letter will be issued to any candidate through postal/Courier means.
