

- v. The last day of submitting applications is September 11, 2021.
- vi. By hand applications will not be accepted/entertained.
- vii. The competent authority reserves the right to cancel the process, the number of disciplines as per requirement against any post at any stage without assigning any reason.
- viii. No TA/DA will be admissible for written test/interview.
